Just Us

GSR/GSR-A NAME: Kellye J.

GROUP REPORT:

Just Us is a closed Narcotics Anonymous meeting for addicts only. Our meeting format is a combination of literature study and discussion on the reading followed by open discussion. We meet Saturdays at 5pm at Christ Church Cathedral (not affiliated), 425 S. 2 nd St. in downtown Louisville. Park in the back and use the back entrance. Our group report was transcribed incorrectly from the submitted written report in the 01-Feb-2026 LASCNA meeting minutes. I reached out to the secretary about this issue through the LASCNA secretary email address but did not receive a response. I am including the information in my report from 01-Feb-2026 along with our group report for 01-Mar-2026.

In 2025, 681 addicts attended, including 95 newcomers. We collected \$2243.25 in 7 th Tradition. From this we paid \$360.00 in rent, \$243.81 was paid to LASCNA for literature, key tags and medallions. \$1133.89 was sent to NAWS, and \$505.55 was donated to LASCNA.

In January 2026, 87 addicts attended. Just Us collected \$270.00 in 7 th Tradition. \$30.00 was donated to LASCNA, \$332.58 was sent to NAWS, and \$7.42 was paid to LASCNA for literature.

In February 2026, 46 addicts attended, including 4 newcomers. We collected \$126.00 in 7 th Tradition. From this, \$26.75 was paid to LASCNA for literature, key tags and medallions, \$69.25 was sent to NAWS and \$\$30.00 was donated to LASCNA.
