We are currently taking in  $10/\underline{16}$  meetings into facilities who do not have access to regular NA meetings.

We still have many needs left unmet and are in need of dedicated members of NA to give back to our community. 30 days clean is the only requirement to initially serve as a silent panel member, but we especially need addicts with at least a year clean to serve as a panel leader to reestablish meetings in facilities with no access to the message of Narcotics Anonymous. Facilities are flooded with addicts seeking recovery and our message is not reaching them because there is a lack of recovering addicts willing to serve.

GSR's, I ask that you please share this message at your home groups so we can continue to spread the message of Narcotics Anonymous to those seeking recovery!

The H&I Subcommittee is now meeting the same day and same location as Area at 1:30.



#### April 8, 2018 RCM Report

Good afternoon family,

Thanks for allowing me to be of service to the area. I attended the regional meeting in Bowling Green on March 18<sup>th</sup> and when I attend in May at Evansville the Louisville area will again have voting status with the region.

The region had a treasury balance of \$26,201.76 at the start of the regional meeting. It was voted on the floor to give the OVANA PR committee \$1184.00 to fund putting racks with literature in 30 facilities in southern Indiana to help get the message out to suffering addicts. I don't have a list of the actual facilities but they are mostly hospitals and institutions that active addicts frequently visit. The ARANA requested seed money for KRCNA 33. Several areas have been requesting funds for various ways to help carry the message to the suffering addicts and are turning in receipts and detailed reports of where money is being spent. I suggest that if the region is not going to send funds to world that we find ways to use the monies in the areas for outreach or other committees that could use funds to help carry the message of recovery.

The RD for our region is requesting information on the number of meetings and H&I meetings that are active in the Louisville area for a survey being conducted at the WSC. He will be attending the service conference at the end of the month and if anyone has any ballot sheets to turn in you can get them to me or send them to him.

KRCNA was held last weekend in Owensboro at the new convention center and it was a success. The facility was very nice and turnout was moderate. The committee did a very good job and the message was carried to many.

The combined region of BARCNA and Kentuckiana, KBARNA is now the registered region for Kentucky at the WSC. This year our RD and the RD from BARCNA will be attending the conference. It has been requested that the regional meeting in Louisville for July be moved to the fourth Sunday instead of the third to combine the bi-annual KBARNA meeting and the regional meetings for both regions to meet in one location for a summary of the conference and future planning between the regions. A location is yet to be determined if anyone has any suggestions of a location available for the entire day please get with me.

I have not submitted a budget for the RCM nor will I be requesting any funds from the area this month but will submit a budget at the next area meeting.
