We also have an outstanding un-cashed check #2691 written to Ernie's Print Shop for \$250.00 for August Area Minutes. When we take away our \$5000 prudent reserve we actually have \$6,977.50 left in expendable income for which to conduct business. All of our other normal bills for the month of August have been paid. In August we wrote checks for \$5186.42 and deposited \$5890.19. We deposited \$703.77 more money in our account than checks that were written in the month of August. All the transactions are listed at the end of this report.
